Pilot Scheme on Dental Services (Dental Scaling) for Civil Service Eligible Persons

I write to inform you that the Government will soon launch the Pilot Scheme on Dental Services (Dental Scaling) for Civil Service Eligible Persons (the Pilot Scheme), under which some civil service eligible persons (CSEPs) will be arranged to receive dental scaling services from private dental clinics.

In order to explore the provision of fringe benefits by new and up-to-date service delivery modes, and to prevent the further lengthening of waiting time for dental services due to manpower shortage, the Government has identified the dental benefits of CSEPs as the trial area, where some CSEPs will be arranged to receive an one-off free dental scaling from private dental clinics under the Pilot Scheme. The Pilot Scheme is expected to help shorten the waiting time for government dental services for CSEPs. Those participating in the Pilot Scheme can receive dental scaling services at a time earlier than their original appointments at Government Dental Clinics, and the consultation time slots thus freed up can be allocated to others for recall appointments or new consultations.

The Pilot Scheme will cover a service period from 1 August 2023 to 31 January 2025, lasting for 18 months. The Department of Health will invite over 140 000 CSEPs with no history of serious oral diseases and with scheduled routine dental check-ups in or after January 2024 to participate in the Pilot

Scheme. We have informed CSEPs of the relevant details of the Pilot Scheme through bureaux/departments vide our memo dated 20 July 2023, a copy of which is attached for your information.

Pilot Scheme on Dental Services (Dental Scaling) for Civil Service Eligible Persons

The Government will soon launch the Pilot Scheme on Dental Services (Dental Scaling) for Civil Service Eligible Persons (the Pilot Scheme), under which some civil service eligible persons (CSEPs) will be arranged to receive dental scaling services from private dental clinics (PDCs). Please bring this memo to the attention of all staff in your department who are eligible for civil service dental benefits.

Purposes of the Pilot Scheme

- 2. In order to explore the provision of fringe benefits by new and up-to-date service delivery modes, and to prevent the further lengthening of waiting time for dental services due to manpower shortage, the Government has identified the dental benefits of CSEPs as the trial area, where some CSEPs will be arranged to receive an one-off free dental scaling from PDCs.
- 3. On the whole, we expect that the Pilot Scheme will help shorten the waiting time for government dental services for CSEPs. Those participating in the Pilot Scheme can receive dental scaling services at a time earlier than their original appointments at Government Dental Clinics (GDCs), and the consultation time slots thus freed up can be allocated to others for recall appointments or new consultations.

Operational Arrangement of the Pilot Scheme

4. The Pilot Scheme will cover a service period from 1 August 2023 to 31 January 2025, lasting for 18 months. The Department of Health (DH) will invite over 140 000 CSEPs with no history of serious oral diseases and with scheduled routine dental check-ups in or after January 2024 to participate in the Pilot Scheme. Starting from late July 2023, DH will invite eligible persons in batches through SMS (according to the order of their appointments at the GDCs) to participate in the Pilot Scheme. The invitation SMS, sent under the name of "HKDH", will be issued to the invited persons about six months before the dates of their original

recall appointments. If the invited persons agree to participate in the Pilot Scheme, they have to call one of the designated PDCs under the Pilot Scheme to make an appointment for dental scaling services within one month upon receipt of the SMS notification. To ensure proper utilisation of the dental scaling service quotas, the participants are required to complete the dental scaling within three months from the date when they first received the SMS notification.

- 5. Participation in the Pilot Scheme is voluntary. If the invited persons decide not to participate in the Pilot Scheme, they do not need to reply to the SMS from DH and can attend the recall appointments at the respective GDCs as originally scheduled. For those persons holding scheduled appointments for routine dental check-ups but have not received any SMS invitations from DH before the appointments, it means that that they have not been invited to participate in the Pilot Scheme. They should attend the recall appointments at the respective GDCs as originally scheduled. The flow charts of making and changing/cancelling an appointment for dental scaling services under the Pilot Scheme are set out at Annex.
- 6. The original appointments of the invited persons at GDCs will be cancelled automatically after they have successfully made appointments for dental scaling services at PDCs. As such, for those who have successfully made appointments for dental scaling services under the Pilot Scheme but subsequently cancel the appointments for whatever reason, and eventually have not received the dental scaling services within the specified period, they will have to contact the respective GDCs which they have been visiting to queue for the next recall appointments afresh.
- 7. If the PDCs participating in the Pilot Scheme identify any dental problems of the participants during the dental scaling procedure, they will record the problem(s) in a designated computer system for follow-up by DH. All participants in the Pilot Scheme will receive an SMS from DH on the following day upon completion of dental scaling at PDCs, notifying them of the next recall appointments at GDCs and inviting them to fill in a service opinion questionnaire. The questionnaire will not collect any personal information, and all views and information collected will only serve the purpose of reviewing the Pilot Scheme.



謹此通知貴會,政府即將推出公務員及合資格人士牙科服 務(洗牙)先導計劃(先導計劃),安排部分公務員及合資格人士 到私營牙科診所接受洗牙服務。

為探討以更切合時官的新形式提供附帶福利,以及為避免 牙科服務的輪候時間受人手減少影響而進一步延長,政府會以公務 員及合資格人士的牙科福利作為試點,透過先導計劃安排部分公務 員及合資格人士到私營牙科診所接受一次性免費洗牙服務。先導計 劃預期有助縮短公務員及合資格人士輪候政府牙科服務的時間。參 與先導計劃的人士,可早於其原先在政府牙科診所的約期接受洗牙 服務,相應騰出的應診時段可調配給其他就診人士作覆診或牙科新 症之用。

先導計劃的服務期由二零二三年八月一日起至二零二五年 一月三十一日止,為期18個月。衞生署將會邀請超過14萬名無嚴重 口腔病史,以及其牙科定期檢查預約日期為二零二四年一月或之後 的公務員及合資格人士參與先導計劃。本局已於二零二三年七月二 十日發出便箋,透過各局/部門把有關先導計劃的運作安排通知公 務員及合資格人士。隨函附上有關便箋,以供參閱。

政府即將推出公務員及合資格人士牙科服務(洗牙)先導計劃(先導計劃),安排部分公務員及合資格人士到私營牙科診所接受洗牙服務。請將本便箋內容告知部門內所有合資格享用公務員牙科福利的人員。

先導計劃的目的

- 2. 為探討以更切合時宜的新形式提供附帶福利,以及為避免牙科服務的輪候時間受人手減少影響而進一步延長,政府會以公務員及合資格人士的牙科福利作為試點,安排部分公務員及合資格人士到私營牙科診所接受一次性免費洗牙服務。
- 3. 整體而言,我們預期推行先導計劃將有助縮短公務員及合資格人士輪候政府牙科服務的時間。參與先導計劃的人士,可早於其原先在政府牙科診所的約期接受洗牙服務,相應騰出的應診時段可調配給其他就診人士作覆診或牙科新症之用。

先導計劃的運作安排

- 5. 参與先導計劃屬自願性質。如獲邀人士決定不參與先導計劃, 毋須回覆衞生署的電話短訊,可按原定約期到所屬的政府牙科診所定 期檢查。若已獲安排牙科定期檢查約期的人士於約期前未有收到衞生 署的電話邀請短訊,即表示有關人士未獲邀請參與先導計劃,他們應 按原定約期到所屬的政府牙科診所定期檢查。有關預約先導計劃下的 洗牙服務和更改/取消預約洗牙服務流程圖載於<u>附件</u>。
- 6. 獲邀人士在政府牙科診所的原有定期檢查約期會在他們成功預約私營牙科診所的洗牙服務後自動取消,故此一旦成功預約先導計劃下的洗牙服務,但最終因任何原因取消預約而又未有於指定限期內接受洗牙服務的人士,需自行聯絡所屬的政府牙科診所重新輪候下一次的定期檢查約期。
- 7. 參與先導計劃的私營牙科診所如在洗牙過程中發現參與先導計劃人士有牙齒問題,會透過指定的電腦系統紀錄情況,以便衞生署作出跟進。所有參與先導計劃人士在私營牙科診所完成洗牙服務後翌日會收到衞生署的電話短訊,通知下一次於政府牙科診所的定期檢查安排及邀請填交服務意見問卷。有關問卷不會索取個人資料,所收集的意見和資料亦只會作先導計劃檢討之用。


